

# 5% GENERAL LIABILITY DISCOUNT

2024-25 PACE SELF-ASSESSMENT TOOL (BEST PRACTICES SURVEY)

PACE members control insurance costs by pooling resources to protect members from property and liability claims. PACE Risk Management's primary mission is to support your risk management efforts, reducing costs to your entity and the entire risk pool while helping promote the safety and well-being of all stakeholders. The early detection and mitigation of potential risks are crucial to these efforts.

PACE Risk Management has developed the Self-Assessment Tool to help focus risk management efforts where help is most needed. After PACE members complete the self-assessment (best practices survey), we will follow up with members that need assistance. ## All you need to do is complete the following best practices survey questions in the insurance portal to receive a 5% general liability discount:

#### 1. EDUCATION

Did at least one person from your entity attend a PACE regional training, <u>quarterly webinar</u> or a <u>previously recorded webinar</u> on risk or legal issues, or have PACE conduct an onsite training?

Have all staff watched the <u>PACE PSA</u> video about bullying and harassment?

#### 2. SEX ABUSE PREVENTION | PACE SAP PAGE

#### K-12, Charter Schools and ESDs:

- Are all schools in compliance with <u>Erin's law</u> and the <u>Healthy Teen Relationships Act?</u>
- Are the <u>"We Got This"</u> and <u>"Mandatory</u> <u>Reporting"</u> posters displayed in every school building?

#### **Community colleges:**

 Have all staff who work with minors watched the Mitigation Minute, "Minors on Campus."  Has your Title IX coordinator scheduled a visit and met with our Sex Abuse Prevention Consultant in the last 12 months? Contact <u>riskmanagement@sdao.com</u> to schedule this meeting.

#### 3. CYBERSECURITY

Are you continuing to maintain all of the cyber requirements that PACE has implemented over the last 3 years? Below are some additional cyber resources:

- CISA for Educational Institutions
- Cybersecurity QRG

Participate in an external vulnerability scan. One option for this scan is through CISA.

Require at least one cyber training for all staff to be included in their annual training rotations.

Test the recovery of your backups to ensure you are able to restore to those backups should your data become compromised.
