- a. ORS 192.660(2)(h) To consult with counsel concerning the legal rights and duties of a public body with regard to current litigation or litigation likely to be filed.

#### III. Action Items

a. Action item(s), if any, pertaining to executive session.

David Kruse moved "authorization to negotiate resolution with Genesis in regard to David Douglas settlement." Brad Henry seconded. None opposed. None abstained. Motion passes unanimously.

- **b.** Underwriting Department presentations and PACE Trust Board action items Property reinsurance:
  - Current market is soft with downward pressure on rates
  - High dollar amount claims this past claim year (Bend-La Pine and Medford)
  - Domestic markets offering quotes of flat to 5% rate increase
  - Excess layers seeing rate reductions of 5-17.5%

Liability coverage:

- Genesis provided primary quote with an 8.8% rate increase
- Retention increased to \$500,000 to \$2.5 million
- Euclid Hudson quote was considered prohibitively expensive

## Market exploration:

- Obsidian: Competitive but lacking rating, not pursued
- Munich Re: Quoted to replace Euclid Hudson without corridor deductible
- Genesis: Provided a backup quote for second layer
- Safety National: Declined due to habitational exposure
- Old Republic: Declined without specific reason

Sexual Misconduct Coverage:

- Original endorsement had defense costs eroding liability limits
- Feedback from agents suggested this was uncompetitive
- Proposed change: Move defense costs outside liability limits
- Consistent with other liability coverage approaches
- Qualification depends on loss history and risk management responses
- K-12 schools need 4 out of 5 acceptable risk management answers for higher coverage
- Community colleges and ESDs evaluated more flexibly

Terrorism Coverage:

- Coming in at approximately a 15% rate reduction
- Quotes received from existing markets
- Renewal is consistent with previous coverage

Equipment Breakdown Coverage:

• Renewal quote is coming in at essentially flat rates

- No significant changes or increases noted
- Quotes received from current markets
- i. Property reinsurance- Chris Hill, Cliff Simpson and Katie Rector
  - a. "I would seek a resolution to deal with the property reinsurance matrix, to authorize staff to complete binding coverage for the 25-26 coverage year, as long as that coverage stays substantially within budget and within our existing coverage documents."
